2. Each of these cases raises common issues of law, specifically relating to the authority and duties of DNR when acting on high capacity well applications.

4. Case No. 16-CV-2816 is the first action filed among these cases, and this Court therefore is the proper court to determine this motion under Dane County Circuit Court Rule 312.

5. The Petitioner and Respondent believe that the consolidation and joint briefing of and decision on the issues in these cases will promote judicial efficiency and timely resolution of the issues raised herein.


